Activity of the Planning Commission during the period of July 1, 2024 to September 8, 2024:

### Town Comprehensive Plan 5-year review:

The Office of State Planning formally acknowledged that the Town completed the 5 year review process. A copy of the letter is attached for reference and electronic copy was sent to Mayor Fox by the State Planning Office.

#### 11 Lombard Street Shed:

The Commission Chairperson received a few inquiries from residents related to a shed placed at 11 Lombard Street. It would appear that the shed was placed without a permit. While the size of the shed would normally not require such a permit, since it is located in the Flood zone, a permit is required. To the knowledge of the Chairperson, no request was submitted for approval of placement of the shed. Chairperson Geller notified Mayor Fox of the inquiries on 9/1/24. The resident reached out to Chairperson Geller on 9/8/24 for guidance on requirements. Chairperson Geller informed the resident of the requirements for the shed in the floodzone and process of obtaining a permit permission letter from the Town prior to applying for a permit at the County.

#### **Planning Commission meeting:**

The Commission members agreed to cancel the meeting slated for August 20, 2024 as there was no pending matters before the Commission.

The next scheduled meeting of the Planning Commission is set for October 22, 2024 at 6:30pm at the Town Hall.

This letter confirms receipt of and concurrence with Leipsic's completed five-year review process for the 2019 Comprehensive Plan, as documented in the enclosure dated July 1, 2024. Congratulations on completing the town's five-year review process!

As you are aware, 22 Del. C. § 702 states that "every 5 years a municipality shall review its adopted comprehensive plan to determine if its provisions are still relevant given changing conditions in the municipality or in the surrounding areas. The adopted comprehensive plan shall be revised, updated and amended as necessary, and readopted at least every 10 years." Leipsic's plan was certified on May 6, 2019, and the deadline for the five-year review was May 6, 2024. This letter documents that you coordinated with our office in advance of that deadline and established a timeline to complete the process in a timely manner. We greatly appreciate your time and attention to this review process.

Upon review of the submitted documentation, OSPC acknowledges that the town completed a review process through Mayor Fox and the Planning & Zoning Commission. Therefore, this satisfies Leipsic's five-year review requirement. The next required update of the Comprehensive Plan is due for certification by May 6, 2029.

Our office looks forward to working with Leipsic in the future during the next full update of the plan.
