Minutes of the previous meeting dated 5/1/23 were read silently and approved.

Guests: Mark Stallman, 161 2<sup>nd</sup> street was present and paid (3) years of back taxes and permission For a shed was tabled until further steps are taken & reviewed at the Sept 11, 2023 town meeting.

Building /Land use Applications & Permits: Permission Letter was issued to Cheri Knies for a shed. Treasurer's Report: Read and approved.

Tax Collector Report: Read by Treasurer and approved. Tax Collector Cathy Manley was absent.

Old Business: Route 9 Stop Signs are reported to be placed in August.

Neighbors were complaining about the Tall grass on 2<sup>nd</sup> St. owned by: A & E Property Solutions LLC. Contacted the Sheriff's office and the Complaint Dept. had it mowed & working on having it condemned.

Mayor of Little Creek/Ed Strouse called and stated that Speed Cameras are legal now, but we need Police Patrol to qualify. Bowers beach & Little Creek have agreed to share expenses for Police and want to know if Leipsic is interested. Told him I would let him know after July Meeting. Ed will arrange a meeting if everyone is in agreement.

Prices for everything are going up/V.P. of Levy Court reported that "Sewer Bills" will increase \$40.00 or \$50.00 next year. Also, County Taxes will increase according to the "Reassessment" Per: Allen Angel, some will go up & some will go down.

Delmarva Power Rates will increase by: \$9.91 or \$12.47 per month effective June 1, 2024.
